We offer 1-2-1 solution focused hypnotherapy (SFH) & psychotherapy sessions with children and young people over the ages of 8 years old, with a parent or guardian accompanying the child or young person. This is the case if the session is face to face or online using Zoom.

We store records for each child and young person until their 23rd birthday, as per the best practice guidelines.

We are signed up members of the Association of Solution Focused Hypnotherapy (AfSFH) and agree to be aware of best practice when conducting therapy online with vulnerable individuals (including children). If therapy is being conducted online, we follow the AfSFH guidelines for 'Conducting SFH Online'
